Old Business: The Oneida, LLC

The Oneida LLC is requesting the full suite of IDA benefits including mortgage recording tax abatement, sales tax abatement, and the standard IDA PILOT agreement. The City of Oneida and community are all in full support of this project. Hicks presented a letter from the Mayor Helen Acker offering her full support. A Commercial Retail Findings resolution is included due to the retail and housing aspects of the project. The Oneida LLC, is the keystone project to a distressed area of Oneida that is in a census tract and will be receiving \$3.1 million of the \$10 million Downtown Revitalization Initiative (DRI) award. The developer is Ed Riley who had great success developing the Hotel Syracuse. Hicks mentioned plans for parking are continuing to be discussed. The public hearing for IDA benefits was held on October 17th, with members of the City present and all in full support. Bargabos clarified that a company is able to come back to the IDA and request an extension on sales tax abatement, and mentioned to Hicks to ensure the applicant is aware, before overspending/ potentially creating a claw back situation. The IDA Board is looking forward to a meeting at Shaughnessy's pub when the Oneida is opened.
